Release of Liability and Indemnification Agreement

I fully and forever release and discharge all groups, their affiliates, agents, volunteers, officers, directors, employees, successors and assigns from any and all negligent acts and omissions in connection with or in any way relating to my presence on CCE property with my dog(s).
