Dog Rules at Niagara Celtic

- Upon arrival all dog owners are required to sign a waiver.
- Dogs & owners who fail to comply will be asked to leave; no refunds will be given **no matter the reason**.
- Dogs must be spayed/ neutered, up to date on all shots and rabies vaccinations, and be wearing appropriate tags.
- No puppies under 6 months are allowed (they are not old enough to meet the medical requirements listed above)
- Visiting dogs must behave well around other dogs/ animals and very large, unpredictable noises and large crowds of people.
- All dogs must be leashed at all times, and owners must clean up after them. Leashes must be under 6 feet; no flexi-leads allowed.
- All incidents must be immediately reported to First-Aid near The Great Hall.
- Non-Service dogs are not allowed in any buildings.
- Dogs are not allowed to enter any children focused areas (notices are posted nearby).

Release of Liability and Indemnification Agreement

- I acknowledge that I have voluntarily brought a dog to the Niagara Celtic Heritage Festival, held on the Niagara County Fairgrounds/ CCE of Niagara's property.
- I agree to pick up after my animal(s) and dispose of all waste in appropriate containers.
- I agree to maintain control of the animal(s) by an adequate leash at all times while on CCE property. The length of the leash must be no longer than that which is reasonably necessary to prevent the animal from chasing, attacking or coming into uninvited contact with any person, animal or vehicle.
- I understand that being physically present on CCE property with my dog(s) necessarily involves risks of injury to me, to other people, to my dog(s), and to other animals, as well as risks of harm to the personal property of others. I understand all of these risks are entirely my responsibility. I expressly and voluntarily assume all such risks, loss, damages, or injury that may be sustained to persons, animals, or property in connection with or relating in any way to my presence on CCE property with my dog(s).

By signing this release of liability, I hereby fully and forever release and discharge Niagara Celtic Heritage Society, Inc. and CCE-Niagara, their affiliates, agents, volunteers, officers, directors, employees, successors and assigns from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of my presence on CCE property with my dog(s). I fully and forever release and discharge all groups, their affiliates, agents, volunteers, officers, directors, employees, successors and assigns from any and all negligent acts and omissions in connection with or in any way relating to my presence on CCE property with my dog(s).

By signing this agreement, I also agree to indemnify and hold harmless Niagara Celtic Heritage Society, Inc. and CCE-Niagara, their affiliates, agents, volunteers, officers, directors, employees, successors and assigns (the "Indemnified Parties") from any claims, demands, damages, costs including attorney's fees, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, whether grounded in tort, contract, strict liability or otherwise, brought against any or all of the Indemnified Parties as a result of my presence on CCE property with my dog(s).
